## US exempts aviation, space exports from new Russia sanctions

AP ■ WASHINGTON

The Trump administration has decided to exempt aviation safety and space exploration technology from new sanctions it has levied against Russia in connection with the poisoning of a former Russian spy and his daughter in Britain.

The State Department said late Friday that products related to those sectors will not be automatically subjected to an export ban that was announced by President Donald Trump this week. The sanctions do include a presumption of denial or export licenses for items that could be used in the production of chemical and biological weapons.

They also mean the US will oppose loans or other assistance to Russia by international financial institutions like the World Bank and International Monetary Fund and bar US banks from participating in non-ruble Russian debt financing. The export ban

and financing restrictions are part of a package of sanctions imposed on Russia over the March 2018 poisoning of Sergei Skripal, a former Russian military intelligence officer turned double agent for Britain, and his visiting daughter, Yulia.

The pair were found unconscious on a park bench in the British town of Salisbury after being exposed to the nerve agent Novichok.

They spent weeks in critical condition but recovered.

The new US sanctions will take effect in September and will remain in place for at least a year.

They can only be lifted after that yearlong period if the administration certifies to Congress that Russia has provided reliable assurances that it is not making preparations to use chemical weapons, will not use chemical weapons in the future, has allowed international inspectors to verify those assurances, and has paid restitution to the victims of the

## Trump invited Iran FM to White House: Report

Washington: US President Donald Trump invited Iran's foreign minister to the White House last month at the height of tensions between the two countries, a magazine reports. The invitation, extended by Senator Rand Paul with permission from the president, was turned down for now, The New Yorker reported Friday.

The minister, Mohammad Javad Zarif, said it was up to Tehran to decide on accepting it. Neither the White House nor the State Department responded to AFP requests for comment on the report, which quoted US and Iranian sources and what the magazine called a well-placed diplomat.

Zarif told the magazine he would not want a White House meeting that yielded just a photo op and a two page statement afterwards, The New Yorker said. Trump has said publicly several times that he is willing to hold talks with the Iranians even as he lambasts Tehran as a corrupt, incompetent and dangerous regime that is a threat to regional security and US interests.
